APPROVAL OF MINUTES:

Commissioner Innes moved that the Traffic Safety Committee approve the minutes of July 26, 2016, as presented, seconded by Commissioner Moore. Motion passed unanimously.

NEW BUSINESS:

Item 4(a): Crosswalk Enforcement

Sergeant Aydt reported that the grant funded crosswalk enforcement events over the summer were successful and the Police Department plans to conduct the events next year when the traffic is not so heavy.

Item 4(b): Moveable Radar Reader Board

Sergeant Aydt said the reader board has been placed in several areas of the city. He asked that citizens let the Police Department know if they would like the board placed in a specific location. He had not yet received the data on speeds at most recent reader board locations, but he reviewed data taken at 20th and Irving, which indicated most drivers are going 25 to 30 miles per hour in that area.

Director Cronin added that the reader board would be deployed on Bond Street as part of the Bond Street Project.
